Michael Cicherski has been caving regularly since the late 80s. He is a Fellow of the National Speleological Society and a recipient of the National Speleological Society Certificate of Merit.

Michael has personally explored Honey Creek Cave many times, a cave described by some as being "dark, creepy, and cold!" The mouth of the cave is on privately-owned land which was recently placed in a conservation easement by its owners to ensure its protection in perpetuity. With 20 miles of cave already documented, it is the longest known cave in Texas.


Share your opinion




"DEEP IN THE HEART"

RELAYING AN URGENT REQUEST FROM ONE OF OUR PARTNER ORGANIZATIONS:


The Preserve Our Hill Country Environment is asking for help getting TCEQ to hold a public hearing on yet another wastewater discharge permit in Comal County. Requests for the public hearing must be received by TCEQ by March 1 and can be made online. You can also contact Senator Donna Campbell and Representative Carrie Isaac to ask them to request a public meeting, but you'll have to act quickly. Read the details below if this is something you'd like to help with.



# Stop 3009 Vulcan Quarry

Permit Filed for 600,000 GPD Wastewater Discharge into Dry Comal Creek, Comal River

A permit application has recently been filed to dump up to 600,000 gallons of treated sewage—every day—into the West Fork Dry Comal Creek and Dry Comal Creek, which flow into the Comal River in New Braunfels. The discharge location would be just west of the proposed Vulcan quarry—right over the Edwards Aquifer contributing zone and just 2000 feet upstream from the recharge zone. At this point, it appears that TCEQ plans to approve the permit application—without even holding a public meeting. But we can change that!



We need your help! And we need to take action fast—no later than Wednesday, March 1. Here's what you can do—two easy steps:

### 1. Submit comments to TCEQ

Go to www14.tceq.texas.gov/epic/eComment and enter WQ0016211001 in the Permit Number box. Complete the form (either type in the comments box or attach a file) and click Submit to TCEQ. We suggest the following:

· Request a public meeting.

If you live in the area—especially if you are on a private well—state that you are an affected person (e.g., because of the location of your water well, you depend on water from the Edwards Aquifer, etc.) and request a contested case hearing.

Permit application should be denied.

Potential negative impact on groundwater quality (i.e., area water wells, Edwards Aquifer, Trinity Aquifer).

Potential negative impact on area streams and rivers (Dry Comal Creek, Comal River, Guadalupe River).

No plan for beneficial reuse or land application (TLAP).

Potential negative impact on area caves and caverns.

We recommend keeping your comments short and simple. But if you want a deeper dive, feel free to reference this letter from PHCE or this letter from GEAA.

# 2. Contact Representative Carrie Isaac and Senator Donna Campbell

TCEQ rules state that if a state legislator representing the area requests a public meeting, TCEQ will schedule a public meeting. We have reached out to both, but so far neither Senator Campbell nor Representative Isaac has done so. Apparently they need to hear from more of their constituents!

Please call AND email both and ask them one thing: to request a public meeting on TCEQ permit WQ0016211001.
