These resources could be instrumental in guiding and shaping responsible commercial real estate projects in the region.

The significance of conservation, from an economic and ecological standpoint, cannot be overstated. The data is consistent and compelling, illustrating the substantial returns that investments in conservation provide. For every dollar invested in conservation, there is a return of four to eleven dollars in the form of natural goods and services, including clean air, clean water, and reduced flood risks. This not only has a positive impact on the environment but also enhances the appeal and value of real estate. Conservation also plays a significant role in reducing the cost of water infrastructure, translating to savings of six dollars for every dollar invested in land conservation for water protection. These figures highlight the potential financial benefits of conservation and responsible development measures in the Hill Country.

The economic advantages are not the sole benefit of conservation. Outdoor recreation generated a staggering \$37.5 billion in Texas in 2021, reflecting the cultural and recreational value of the natural infrastructure. It provides opportunities for boating, fishing, hunting, and a range of other activities that drive local economies. Additionally, close-to-home access to green spaces is essential for maintaining physical and mental health, thereby reducing healthcare costs.

At the heart of this entire effort is a profound connection with nature. Survey respondents emphasize that the primary reason for seeking access to parks, trails, waterways, and open spaces is to connect with the natural world. This connection fulfills a fundamental human need, offering solace and inspiration. The shared love for the Texas Hill Country's natural beauty underscores the significance of the Land, Water, Sky, and Natural Infrastructure Plan.
